4. To maintain good business practices with regard to colleagues, clients or suppliers in the industry of IFEAT. The practices shall include but not be limited to timely payment of financial obligations resulting from either sale or acquisition of products, as outlined in written documentation which has been agreed by both parties to the sale or acquisition.
5. To register for any IFEAT events that we attend or in which we participate in any way.
6. To acknowledge the process of the conciliation services offered by IFEAT.
7. Should the issues of a breach of good business practices not be resolved by the IFEAT Executives, we understand that we may be suspended from membership of IFEAT, after due process has been followed in this regard, and we have been notified accordingly.
8. We further understand that if we are suspended as a member of IFEAT and further issues of a breach or violation of good business practices are brought to the attention of IFEAT, this breach or breaches may result in our business being expelled from the membership of IFEAT.
9. We understand that if we are suspended or expelled from IFEAT membership, IFEAT may at its sole discretion notify its members of our expulsion and the reasons for expulsion and require us to not attend IFEAT events. We understand that for the period of suspension or in the event of expulsion, we will not be allowed to hold ourselves out as members of IFEAT.
10. We understand our business may be suspended and/or expelled from membership of IFEAT if we do not abide by this Code or the current Articles of Association, and all provisions above related to suspension or expulsion of an IFEAT member will apply.
