



IFEAT 2024 Bangkok - *Shaping the Future: from Asia to the World*

CALL FOR PAPERS

About the Conference

The 2024 IFEAT Conference will take place from **10th to 14th November 2024** at the Marriott Marquis Queen's Park Hotel, Bangkok, Thailand.

Bangkok is Thailand's capital city and trading centre, situated beside the Chao Phraya River. It is popular for its ornate shrines, magnificent palaces, skyscrapers, museums, markets, and vibrant streets. The city attracts tourists from around the world. The boat-filled Chao Phraya River feeds its network of canals, flowing past the Rattanakosin royal district, home to the opulent Grand Palace and its sacred Wat Phra Kaew Temple. Also of renown is Wat Pho Temple with its huge reclining Buddha and on the opposite shore Wat Arun Temple with its steep steps and Khmer-style spire.

The theme for Bangkok is ***Shaping the Future: from Asia to the World***

Topics for discussion include the following and we would welcome submissions for papers that deal with or relate to these topics:

1. Asia is the production hub for most aromatics contributing almost 65% of the total essential oil production, with a similar percentage in aroma chemical production. With increasing environmental challenges in Europe, production centres are now moving to Asia.
2. The emerging legislative and regulatory challenges in Europe and the Americas have a significant impact in Asia as there is very little harmonisation of regulations globally.



3. Asia is the fastest growing market for the F&F Industry while also being the production hub - what impact does this have on the way business is conducted? How does the traditional F&F industry, which was centred around Europe and the Americas, adapt?
4. "Aromatherapy: Fad or Here to Stay?" What regulations should apply?

Presentation Proposal/Abstract

We invite you to submit an abstract of what you propose to present at the Bangkok Conference.

Presentation proposals accepted include scientific, technical, commercial, or economic papers, lectures, workshops, and panel discussions with experts. Presentations should be a maximum of 25 minutes (plus five minutes question time). You may submit more than one proposal but a maximum of three.

Please outline how you will ensure that your presentation is engaging, informative, educational, and relevant to the F&F industry audience. Please note, you may not advertise or promote your company/organisation's products or services in your presentation. Your logo can be added to your first and last slides.

Abstract/proposal deadline – no later than Friday 8th March 2024.

Your proposal will then be put forward for consideration by the Bangkok Conference Committee.

You will be informed of their decision by **Friday 26th April 2024.**



Please supply:

- **Your abstract/proposal (max 250 words)** - an outline of the topic of your presentation and why your presentation/paper is relevant to the F&F industry and the Bangkok Conference, and how it ties in with the theme.
- **A short biography of yourself** - a paragraph or two (maximum 100 words) but not a CV.
- **Your contact details** - name, company, address, email, phone & website.
- **A high-resolution colour head and shoulders photograph** (minimum file size 1mb).
- Details of other speaking engagements you have had (if any).
